



SUPPLY AND DELIVER ACCESSORIES FOR PALLET RACKS
Bill of Quantities (BQ)

1. The Bidder's price as stated in this section Bill of Quantities shall be on a firm price basis in Brunei dollars (BND) and shall be inclusive of all costs, expenses, charges, taxes, duties, insurance, transportation, Delivery, etc.
2. Materials must be individually packed in protective seaworthy wooden casing which must be labelled in the following manner:

3. Pallet rack accessories must be manufactured and distributed by an approved factory such as listed below. If Bids are submitted with non-compliant factories without prior BPC review, this will result in disqualification of contractor's bid offer.

4. Materials and accessories must be manufactured from the same factory and country of origin and come with factory certificates and mill reports.
5. Manufacturing of pallet racking system, including safety, design, testing, and production control systems shall comply to EN 15512 or equivalent standards, approved in 2009 by the CEN. The system must also fulfil safety requirements and guarantees of safety under these standards. The Bidder shall submit a letter of guarantee from the manufacturer with this bid offer.
6. All Materials quantified in this schedule must be equally divided and packed into wooden crates for lifting and transportation.
7. The contents and quantities of each crate must be itemised as per the schedule of pricing. All dimensions given in this schedule are approximate only, and the bid items must not be smaller than the specified dimensions.
8. The Bidder must fully comply with the Material specifications in this schedule. Alternative materials will not be accepted.
9. The manufacturer's factory must be stated in the Bid, and manufacturing facilities, quality control and assurance, manufacturing standards and factory brochures must be submitted with this Bid. Manufacturer must have valid ISO9001 certification.
10. The contractor is responsible to pay all taxes, fees, shipping and transportation to BPC Stores. Transportation and lifting vehicles including safe lifting accessories must have valid certificates of safety as inspected by an accredited inspection agency in Brunei. BPC reserves the right to refuse acceptance of goods if safety certificates are expired or not available on demand. Goods will be paid for in full amount upon BPC receiving contractor's invoice claims complete with material delivery order signed by a BPC store employee.
